Terms of Service

These Terms of Service (the “**Terms**” or “**Agreement**”) are between you and VIASAT BRASIL SERVIÇOS DE COMUNICAÇÕES LTDA, a Brazilian limited company, with an office located R. Gomes de Carvalho, 911 - Vila Olimpia, São Paulo - SP, 04547-003, Brazil (“**Viasat**”). Checking the box as you log on to use the Service represents your affirmative opt-in agreement to these Terms. If you do not agree with these Terms, do not check the box or use the Service, and return to the local vendor from whom you made the Purchase (as defined in Section 1(b)) for a refund. You will not receive a refund if you check the box and proceed to use the Service.

1. Using the Service.

a. Obligations. In connection with your use of the Service you agree to comply with all applicable laws and regulations, including but not limited to copyright and intellectual property rights laws.

b. Types of Plans. Unless you have received free Service, in order to use the Service, you must purchase an increment of data plan (a “**Data Purchase**”) or an increment of time plan (a “**Time Purchase**”), or both (“**Combo Purchase**,” and together with Data Purchase and Time Purchase, a “**Purchase**”).

i) **Data Purchase.** Immediately after you enter your pin code and connect to the Service, all uploaded and downloaded data transmitted using the Service will count towards your Data Purchase. If you use more data than the Data Purchase, the Service will cease to work beyond the amount of the Data Purchase. Upon completing a Data Purchase, you will automatically connect to the network and begin using data. You may turn off your Wi-Fi to prevent your device from automatically connecting to the Service. Each Data Purchase plan you buy will expire 30 days after the Data Purchase regardless of whether you have used all of the data under the applicable Data Purchase plan.

ii) **Time Purchase.** Viasat will begin counting your Time Purchase immediately after you enter your pin code and connect to the Service. Your Time Purchase will continue counting down, even if you are not logged into the

Service. The Service will cease to work beyond the amount of the Time Purchase.

iii) **Combo Purchases.** A Time Purchase may include a Data Purchase associated with it (e.g., 10GB for one-week). For Combo Purchases, your Service will cease to work beyond the expiration of the earlier of the associated time component or the date on which you have reached your data limit.

c. **Non-Commercial Use of the Service.** The Service is for non-commercial use, and you agree not to use the Service for commercial purposes.

2. **Payment Terms.** Each Purchase is paid in advance, final, and non-refundable (except as otherwise set forth in this Agreement). Viasat will not provide you a pro-rata refund for any Purchase left unused.

3. **Modifications to the Service.** We may modify, discontinue, or terminate the Service (or any function or feature of the Service) at any time without having any liability to you.

4. **Modifications to the Terms.** We may update or modify the Terms from time to time. Viasat will provide notice of changes in the Terms in any manner acceptable by law, including by posting them on the login page for use of the Service. You should review the Terms carefully before using the Service.

5. **Termination through Expiration of Purchase.** Your Service will immediately cease to work upon the expiration of your Purchase. Any unsaved work still open in a web browser or other application may be lost and Viasat is not responsible for, and will not be able to recover, such data loss.

6. **Termination or Suspension by Viasat.** Viasat reserves the right to terminate the Service and this Agreement at any time (with or without notice), in whole or in part without having any liability to you.

To the greatest extent permitted by applicable law, you agree to indemnify and hold harmless Viasat, and its respective subsidiaries, affiliates, officers, directors, agents, co-branders, licensors, partners, and employees from any claim or demand, including reasonable attorneys' fees, made by any third party arising out of: (a) content you submit, post, transmit, or otherwise make available through the Service, (b) your use of the Service, (c) your violation of these Terms, (d) your violation of Viasat's Acceptable Use Policy, or (e) your violation of any rights of another while using the Service. This Section 13 is for the benefit of us and our respective contractors, information or content providers, licensors, employees, and agents, and each shall have the right to assert and enforce such provisions directly on its own behalf. Other than as expressly stated in this Agreement, this Agreement shall not be deemed to create any rights in third parties.

14. General.

a. Call Monitoring and Recording. For quality assurance, Viasat records and/or monitors telephone calls and online chat sessions between our customers and our agents, employees, and/or affiliates regarding the Service. By using the Service, you (and anyone calling or otherwise contacting us with regard to the Service) consent to any and all call and online chat session recording and monitoring performed by Viasat or our agents, employees, and/or affiliates.

b. Contact Information. You agree that by entering into this Agreement and providing us with your wireless phone number and/or any other telephone number and/or your e-mail address, we or our agents may contact you for any Service-related issues: (a) by calling or texting you at such number(s) using a prerecorded/artificial voice or text message delivered by an automatic telephone dialing system and/or using a call made by live individuals for any account-related issues, and/or (b) sending an e-mail to such e-mail address. c. Applicable Law. Any action related to these Terms will be governed by the laws of Brazil and the federative unit where the Service is used.

d. Entire Agreement. This Agreement, as well as the additional online documents specifically incorporated as a part of this Agreement, constitutes the entire and only agreement with respect to its subject matter between you and us.

e. Miscellaneous. The effective date of these Terms is the date (and time) that you first “accept” these terms in order to receive the Service and terminate at the date (and time) that your Purchase expires or is completed. The provisions of this Agreement, however, that by their nature should continue shall survive any termination of this Agreement.
